- Session 4: in person or by mail starting on **July 20**
- Registration for privates and semi-privates begins on June 15 for session 1&2, on July 10 for session 3 and on July 20 for session 4.

____ I agree that all private & semi-private lessons are **non-refundable and non-transferable** unless of a medical condition that is backed up by a physical doctor's note provided by a medical doctor/physician.

____ I agree there will be a 30% administration fee applied to any refund.

____ I agree that signups for private or semi-private lessons don't begin until **June 15, 2024**.

____ I agree that my private and semi-private classes must conform to the session dates and cannot be split between multiple sessions for consistency purposes.

____ I agree that **no semi-privates** will be **offered in session 4** and **only 60-minute** privates will be available in **session 4**.

____ I agree a receipt duplicate will be a \$15 fee and a returned cheque will be a \$25 fee

____ I agree that in extreme circumstances (emergencies, weather, etc.), L.I.A.C. cannot provide refunds or make up for lost time.

Lessons are **non-refundable** and **non-transferable**

No refunds unless there is a medical reason (medical doctor's certificate) for withdrawing. Refunds are subject to a 30% administrative fee.

Receipt duplicates will be subject to a \$15 administrative fee.

Returned cheques will be subject to a \$25 administrative fee.

Payment is due at the time of registration. **No postdated cheques.**

Private signups do not begin in person or via regular mail until June 15, 2024. Any forms received earlier **will not** be processed

Refund deadline is August 20, 2024.

Because all lessons are progressive, we cannot split a session.

In extreme circumstances (emergencies, weather, etc.), L.I.A.C. cannot provide refunds or make up for lost time.

Waterproof non-spray on sunscreen only. Sunscreen must be applied a minimum of 20 minutes before entering the pool.

Provincial regulation states that **all persons must shower before entering the pool.**

All Parents must remain on the grass at all times & must leave promptly after lessons are over.
